1.	Please provide a <b>thorough</b> description of your program (250 words max)	The EOPS Scholars program provides support services to participants for the purpose of enhancing their retention and graduation rates, ensuring their attainment of career goals, facilitating their transfer from two-year to four-year colleges and fostering an institutional climate supportive to their successes. The program services promote an increase in the number of disadvantaged students who will successfully complete a program of study, with a selected goal, within a designated timeframe. The objectives included in this project were designed to build on the successes already achieved with the current EOPS Program at De Anza and goes far beyond anything done at De Anza before to close the equity achievement gap. The program has a strong foundation, and has developed a comprehensive set of services including academic advising, transfer/career planning and tutoring to be incorporated throughout a student's enrollment to encourage completion of their academic and personal goals.
2.	Please provide how many students are actively engaged in the program. Backing it up with data will help.	EOPS/CARE 2017-2018 839 EOPS/CARE 2018-2019 749  2019-2020 Fall quarter we serving 588 students and to date have currently signed an additional 60 students for Winter quarter. Total at the time of this writing 648 students. We cannot provide documentation as names are confidential. I can provide documentation for the past two fiscal years.

3.	Why is your program important and what is the rationale behind having this program on campus? (250 words max)	The program is set-up where the institution has to support it and it comes with mandates that staff have to follow to ensure students are successful. Whereas, other programs on campus don't have this type of protection, but EOPS is a program that must remain supported any way possible.  What is unique is because it is a categorical program EOPS students receive priority registration.  The program has specific obligations that the students are required to meet and is designed to keep students on the correct pathway for goal completion. We serve students who are both academically and economically disadvantaged. We are dedicated to closing the equity gap surrounding completion and transfer rates among low income and academically disadvantaged students. Other programs have a much higher academic requirement for students to participate in their program that our students would not qualify for.
4.	How will your program expand students' perspectives and positively impact their lives and the community? (250 words max)	Recently at the CCCEOPS conference celebrating EOPS' 50 <sup>th</sup> Anniversary, it was said that students who participate in the EOPS program are most likely to go into the following fields: medical, social work, and counseling. What this means is that students who participate in this program tend to go into service-oriented vocations that benefit whatever community they are a part of.  EOPS is not just a program, but a community. Students learn how to prepare for transfer to a University and beyond, but also for those who do not transfer, they are prepared to go out into their own community with a sense of purpose and pride with what they have accomplished and learned during their time at De Anza. EOPS students participate in workshops together and begin to build a network that results in another level of support among peers. They all walk a similar path, but through this program, they find they don't have to walk that path alone.

One survey goes out to all EOPS Students and the other to those who are graduating or transferring.  See attached.

This will be a tool to provide students with more information than can be provided with a simple flyer.
